# Information relating to the processing of personal data by the German School Association, in accordance with Article 13 of the General Data Protection Regulation (hereinafter: "GDPR"):

We hereby inform you that we process your personal data. Details of this can be found below.

#### Personal data controller:

#### **Data Protection Inspector:**

The controller has appointed Monika Domino-Wolańczyk to act as the Data Protection Inspector, who can be contacted directly, by e-mail: rodo@wbs.pl.

#### Objectives and basis of processing:

Personal data are processed for the following purposes:

- the performance of the concluded contract for the participation in the activities of the Football Academy, including the participation in training sessions and competitions, enrolment in inter-school games, organization and insurance of football trips (Article 6(1)(b) of the GDPR).
- issuing invoices, keeping and maintaining accounting records (Article 6(1)(c) of the GDPR),
- evidence-related purposes, in case there is a legal need to prove facts and to establish, investigate or defend against claims, compliant our legitimate interest (Article 6(1)(f) of the GDPR),
- conducting direct communication with parents, players, teachers and co-operators of the Football Academy and sending information by the Controller via e-mail and/or telephone devices phone calls, SMS messages (Art. 6.1.a RODO),
- taking photographs and recordings of training sessions and competitions as part of the promotion of a Player and of the Football Academy (art. 6.1.a of the GDPR).

## Data recipients:

We take care to ensure the confidentiality of your personal data and limit the processing of your data by other parties. However, due to the need to provide an appropriate organization, e.g. in the field of IT infrastructure, we may make your personal data available to our subcontractors, i.e. external entities. Your personal data may be entrusted to the following categories of recipients providing services to us:

- IT services
- legal services
- · accounting services
- audit services

The Controller may share the data with other entities only within the framework of the applicable law.

### Data retention period:

The personal data provided will be kept for a period of 5 years from the end of the contract of participation in the Football Academy or until any claims arising from the contract expire or are time barred. Whereas in the case of the processing based on a consent given – such data is retained until the relevant consent is withdrawn.

#### **Processing rights:**

You have the following rights in relation to the processing of your personal data:

- the right to access your data,
- the right to rectify (correct) your data,
- the right to delete your data,
- the right to restrict data processing,
- right to object to the processing of data (you have the right to object to the processing of your data)
- the right to transfer your data,
- the right to lodge a complaint with the supervisory authority (President of the Data Protection Office)

#### **Provision of personal data:**

Providing the data is voluntary, but necessary for the implementation of the contract, accounting purposes, debt collection, communication with Parents and Competitors and for the promotion of the Players.
